1. CALL TO ORDER

4. TOPICS

a. SUBDIVISION APPLICATION 2023-0-129

Rocky Mountain Equipment has applied to subdivide the 7.22 acres off the remaining 40 acres lot from the land that was annexed into the Town a couple of years ago. Oldman River Regional Services Commission Planner, Kattie Schlamp, went over the Resolution for Subdivision 2023-0-129 and the eleven conditions recommended.

MOVED by Councillor Feist to approve subdivision application 2023-0-129 with the recommended conditions outlined in the presented resolution.

b. DEVELOPMENT PERMIT NO. 2024-01 – LOT COVERAGE AND HEIGHT WAIVER

The property owner is looking to build a detached garage and the Land Use Bylaw allows for a maximum of 10% lot coverage for accessory buildings. The proposed garage will bring them up to 13% lot coverage. The property owner also is requesting a 2 foot height waiver to build the garage at 17 feet high. The property backs onto a green strip so it does not interfere with any amenities in the neighbourhood. There was no feedback from any adjacent landowners in favour or opposing the requested waivers.

MOVED by Mayor Moore that Development Permit application 2024-01 be approved with a 3% lot coverage waiver and a 2ft. (0.6 m) height waiver to build the proposed detached garage.
